CSO FORUM ON SOCIAL FORESTRY IN ASEAN

Since its establishment in 2012, the Civil Society Organizations (CSO) Forum on Social Forestry in ASEAN has served as a platform for local communities, indigenous people's organizations, and civil society organizations to consolidate and elevate key messages to the members of the ASEAN states through the ASEAN Working Group on Social Forestry (AWG-SF).

Today, over 50 participants representing 40 organizations from 8 countries in Southeast Asia are actively engaged in the forum.

KEY MESSAGES

In line with the ASEAN Cooperation on Forestry, Key Performance Indicators on Food, Agriculture and Forestry, and Strategic Plan of Action of the AWG-SF, the following have to be ensured:

Recognize that indigenous peoples and local communities themselves and their CSO partners are vital actors to achieve the aspirations of equitable economic development in ASEAN Create and Enforce Laws and Regulations that ensure and protect indigenous peoples and local communities' access and tenure rights to their community-managed forest and customary lands Employ Free, Prior and Informed Consent (FPIC) and other safeguards to effectively protect the rights of indigenous peoples and other community forestry stakeholders.

Ensure the full, genuine and meaningful representation and participation of women and men from indigenous and local communities in forest governance



Support Community Forestry Enterprises (CFEs) to Effectively Engage and Equitably Benefit from Trade in ASEAN

Accelerate the recognition of Community Forest Management Areas and recognize the diverse tenure arrangements



Mainstream CFEs in ASEAN Economic Policies and Programs



Secure Sustainable Community Forest Based Livelihoods from Threats



Install participatory and effective forest governance mechanisms at local, national and regional levels

- Improved policy and policy support on securing and promoting community forestry livelihoods
- Enhanced Value chain management, partnership, incentive and support services for community forestry enterprise
- Improved knowledge and capacities on community forestry livelihoods and enterprises of Community Forestry groups
- Sustained consumer campaign on green and fair community products
- Enhanced knowledge in AEC including impacts and opportunities
- Protected IPR of local communities depending on chosen IPR strategy of community (not necessarily WIPO framework)
- Monitored indicators for the ASFN adopted strategies especially for community economy and livelihood

Forest tenure and access rights

- Established a lobby platform in ASEAN/ AWG-SF on sustained dialogue on rights and access of indigenous and forest-based communities
- Established a knowledge sharing/ learning mechanism on tenure and forest access to promote awareness raising and advocacy and strategy development
- Contributed to securing community land titles and community forest agreements

Covernance Mechanisms Safeguards

- Established official regular mechanisms for stakeholder and civil society engagement at the country and ASEAN level
- Supported local and provincial and national working groups with resources and capacity building programs
- Monitored the achievement of national CF targets by reporting for each country
- Established and expanded clearer definition of SF in protected areas/ customary forest/ land

- Established an ASEAN FPIC Guidelines for IPs and other forest dependent communities ensuring full and effective participation in decision making processes
- Ensured and monitored safeguard implementation by the ASEAN Multi-stakeholder
- Established a Regional Forest Related Grievance Mechanism

Community Economy and Livelihoods

Sustainable Community forest based livelihoods in ASEAN secured and self-reliant CFEs effectively engaging and equitably benefitting from trade through mainstreaming in ASEAN economic policies & programs

Forest tenure and access rights

Government establishing and enforcing laws and regulations that ensure and protect indigenous peoples and local communities' access and tenure rights to their community-managed forest and customary lands.

Governance Mechanisms

Realization of self-mobilization of indigenous peoples and local communities and their organizations towards participatory and effective forest governance.

Safeguards

Recognition of customary forests and the adoption and implementation of FPIC in line with the UNDRIP as a minimum standard as well as development of safeguard policies, measures, and mechanisms on social forestry.
